WIKA Beton Raih Gold Award GCG IX 2025

Jakarta, 18 Februari 2025 – PT Wijaya Karya Beton Tbk (WIKABeton) berhasil meraih *Gold Award (B) Excellent* dalam ajang *The Best Indonesia GCG Award IX 2025* kategori *Public Company – Subsidiary of State-Owned Enterprises Company Asset > Rp7 Triliun*.
